



Wales Environment Link Privacy Policy

WEL is committed to protecting the privacy and security of the personal information that we hold. WEL is a data controller for the purposes of the Data Protection Act 1998 and General Data Protection Regulation which comes into force on 25th May 2018. The Director of WEL acts as the designated Data Controller with overall responsibility for ensuring that the organisation complies with this legislation.

This Privacy Policy explains how and why we collect personal information about WEL members and third parties.

WEL processes personal information to enable us to provide a membership service for the benefit of the national public as specified in our constitution, including:

- to administer membership records;
- to fundraise and promote the interests of the charity;
- to manage our employees and volunteers; and
- maintain our own accounts and records.

We sometimes record contact details for representatives of third party organisations as part of WEL's legitimate work activities. Your personal information is secure with us and will never be released to third party companies for their marketing purposes.

The **charitable purpose** of WEL, specified in our constitution, is to promote for the public benefit the conservation, protection, sustainable use and quiet and responsible enjoyment of the natural and cultural heritage of Wales.

Lawful basis for processing your data

We hold WEL members' data based on **legitimate interests**.

We hold personal contact details for WEL's Trustees on the basis of **legal obligation**.

Who is collecting it and how is it collected?

WEL collects data through WEL membership application process, such as contact details for the organisation's Council representative and the organisation's business address. Any member of the WEL staff team may collect your personal data during the course of their work and via interactions with members, enquirers, advisers and representatives of other organisations.

WEL uses Dropbox for Business and Microsoft Exchange to securely store membership data and other contact details in the cloud. Our cloud-based systems are accessible to all WEL staff and use personalised log in and password protection for each member of staff.

Using your information

We may use your information to:

- let you know what we are working on and share information relevant to WEL members' interests
- send you our weekly political monitoring report and other communications
- invite you to WEL events, or other third party events that we think may be of interest
- ask for your support in WEL or member campaigns
- ask for your advice or input to various pieces of WEL work
- ask you to nominate and/or vote on constitutional issues, seek financial contributions to projects, participate in WEL questionnaires/surveys.

Disclosing your information

We will never disclose your information to anyone outside of WEL except where we have your consent or else are permitted to do so by law.

WEL's website and third party websites

WEL's website does not use cookies. Our website may provide links to other websites outside our control; our privacy policy applies only to our WEL website, www.waleslink.org. We are not responsible for the privacy policies of third party sites which may differ from ours. We cannot accept responsibility for any content or links on third party websites.

Storage of information

We will retain your personal information for no longer than we need it to provide our services and/or products to you. We will try to keep personal information which we hold about you up to date, but if you think that we are holding information which is inaccurate then please contact us to let us know.

Accessing your information

Under the GDPR, individuals have the right to obtain:

- confirmation that their data is being processed;
- access to their personal data; and
- other supplementary information

You can request a copy of your personal information verbally or in writing. Rectifying information

Individuals have the right to have inaccurate personal data rectified and this can be done by contacting the WEL office either verbally or in writing (see contact details above).

Right to erasure

Individuals have the right to have personal data erased. This is also known as the 'right to be forgotten' (*this right is not absolute and only applies in certain circumstances*) and this can be done by contacting the WEL office either verbally or in writing (see contact details above).

Changes to our privacy policy

We will keep our privacy policy under review; this policy replaces all previous versions and is correct as of May 2018. New policies will be published on our web site.
